
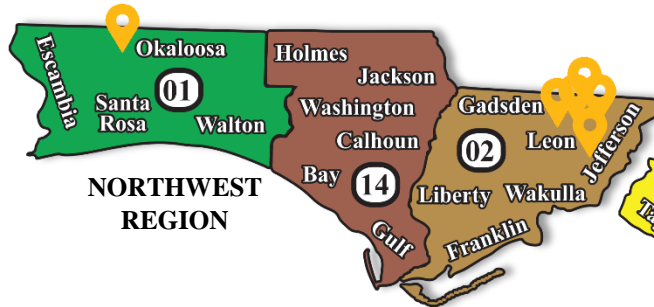

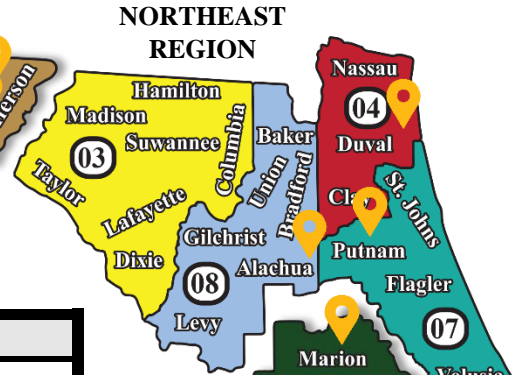

 Estimated location of Council Members

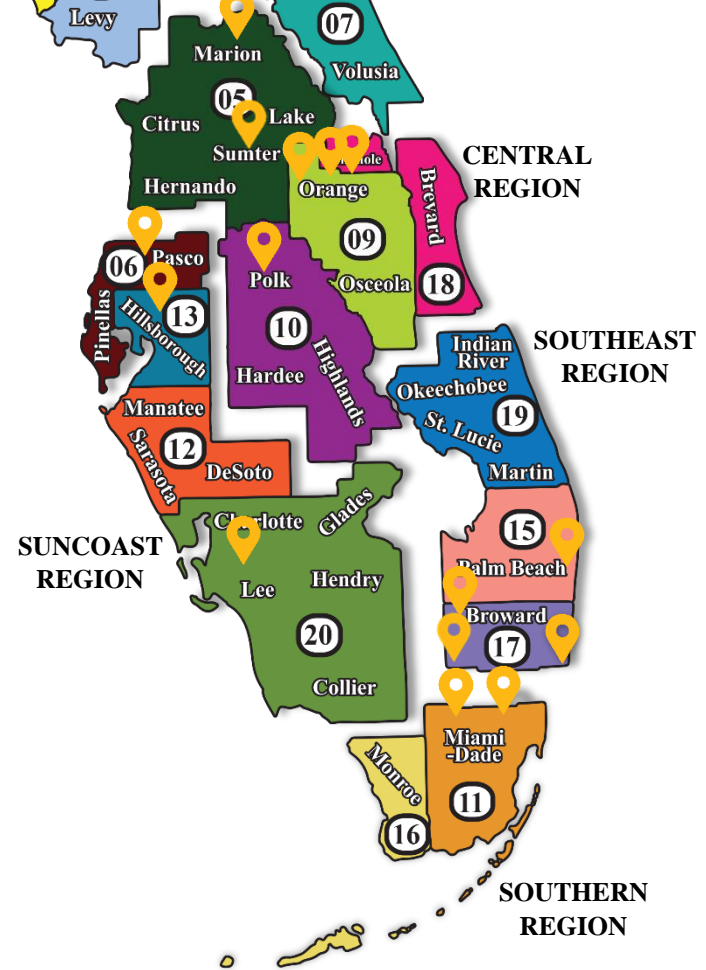
