



**Purpose:** To coordinate the efforts of Cabinet agencies, offices and governmental entities to increase public awareness of shared initiatives and activities that positively impact the lives of children in our state. These efforts are designed to enable the Cabinet to speak with a unified voice and highlight programs and services they can offer to assist children and families.

The survey was designed to capture each Cabinet member's perspective on the entities they feel should be involved with various public awareness topics and entities who should lead the associated initiative or activity (entities selected and identified may or may not reflect those who are statutorily required to participate). The top three entities to lead efforts were identified based on the number of times their name was presented.

A summary of survey responses will be provided for review and discussion on further action steps to enable the Cabinet to fulfill its statutory duties and responsibilities to (5)(e) *foster public awareness of children and youth issues and develop new partners in the efforts to serve child and youth*, and (5)(i) *engage in other activities that will implement improved collaboration of agencies in order to create, manage, and promote coordinated policies, programs, and service delivery systems that support children and youth*.


