You may be eligible for state Reemployment Assistance benefits and extensions if:

- You are out of work due to no fault of your own.
- You meet requirements for wage and work history.
- You are unemployed or partially unemployed and are earning less than your weekly benefit amount.

## PANDEMIC UNEMPLOYMENT ASSISTANCE (PUA)

For Floridians unable to work due to COVID-19 and not eligible for state Reemployment Assistance, including independent contractors and self-employed workers.

Weekly Benefit | Amount (WBA) Maximum \$275

Minimum \$32

+ \$600 Federal Pandemic **Unemployment Compensation** (FPUC)

Weeks Ending April 4 - July 25

+ \$300 Lost Wages Assistance (LWA)

If your WBA is \$100 or more and out of work due to COVID-19.
