OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 15-200

WHEREAS, the Honorable MARK A. OBER, State Attorney for the Thirteenth Judicial Circuit of Florida, has advised Governor RICK SCOTT that Jenae M. Aragosa is under investigation for criminal use of personal identification information and false official statements; and

WHEREAS, the Honorable MARK A. OBER has also advised the Governor that Jenae M. Aragosa was a volunteer in the state attorney's office at the time of the offense and employees of the state attorney's office are potential witnesses in this case; and

WHEREAS, the Honorable MARK A. OBER, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified himself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable BERNIE MCCABE, State Attorney for the Sixth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable BERNIE MCCABE discharge the duties of the Honorable MARK A. OBER, pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RICK SCOTT, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant

to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1.

The Honorable BERNIE MCCABE, State Attorney for the Sixth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable MARK A. OBER, State Attorney for the Thirteenth Judicial Circuit of Florida, as they relate to the investigation, prosecution and all matters related to Jenae M. Aragosa.

Section 2.

The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Thirteenth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.

Section 3.

All residents of the Thirteenth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4.

The period of this Executive Assignment shall be for one (1) year, to and including October 14, 2016.

Section 5.

The Assigned State Attorney shall notify the Governor on or before September 14, 2016, if additional time is required.
