OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 21-95 (State Attorney Executive Assignment)

WHEREAS, the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, has advised Governor RON DESANTIS that Vito Mirra was cited by the Florida Fish and Wildlife Commission pertaining to the violation of reef fish-recreational bag limits: red grouper; and

WHEREAS, the Honorable AMIRA D. FOX has also advised the Governor that Vito Mirra's spouse is a former employee of the state attorney's office; and

WHEREAS, the Honorable AMIRA D. FOX, to avoid a conflict of interest or any appearance of impropriety, has voluntarily disqualified herself and has requested the executive assignment of another State Attorney with respect to the investigation and prosecution of this case and all related matters; and

WHEREAS, the Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, has agreed to accept an executive assignment in this matter; and

WHEREAS, it is in the best interests of the State of Florida and of the ends of justice that the Honorable ED BRODSKY discharge the duties of the Honorable AMIRA D. FOX pursuant to section 27.14, Florida Statutes.

NOW, THEREFORE, I, RON DESANTIS, Governor of Florida, in obedience to my solemn constitutional duty to "take care that the laws be faithfully executed," and pursuant to the Constitution and laws of the State of Florida, issue the following Executive Order, effective immediately:

Section 1. The Honorable ED BRODSKY, State Attorney for the Twelfth Judicial Circuit of Florida, referred to as the “Assigned State Attorney,” is assigned to discharge the duties of the Honorable AMIRA D. FOX, State Attorney for the Twentieth Judicial Circuit of Florida, as they relate to the investigation, prosecution, and all matters related to Vito Mirra.

Section 2. The Assigned State Attorney or one or more Assistant State Attorneys and Investigators, who have been designated by the Assigned State Attorney, shall proceed immediately to the Twentieth Judicial Circuit of Florida, and are vested with the authority to perform the duties prescribed herein.


Section 3. All residents of the Twentieth Judicial Circuit are requested, and all public officials are directed, to cooperate and render whatever assistance is necessary to the Assigned State Attorney, so that justice may be served.

Section 4. The period of this Executive Assignment shall be for one (1) year, to and including April 29, 2022.

Section 5. The Assigned State Attorney shall notify the Governor on or before March 29, 2022, if additional time is required.
