NOTICE OF JUDICIAL VACANCIES-INSTRUCTIONS

As a result of the Supreme Court's Order in Case No. SC13-1333 and the resignation of Judge Lynn Rosenthal, there are two (2) vacancies in the Seventeenth Judicial Circuit Court, in and for Broward County, Florida.

1. Judicial applications for these two (2) Circuit Court vacancies must be received by Noon on Monday, November 9, 2015, at the following location:

Applications delivered after the deadline **WILL NOT BE CONSIDERED**. All applicants must have been members of the Florida Bar for at least five (5) years, electors of the State of Florida, and be resident of the Seventeenth Judicial Circuit prior to taking office. Only one application package is necessary to be considered for both vacancies.

2. The Judicial Application (which can be obtained from the Florida Bar website www.flabar.org) must include:

- An original and nine (9) copies of the application, with the original clearly marked;
- A recent photograph should be attached to the original and each copy;
- All letters of recommendation in your possession that you wish the Commissioner to consider. However, these letters may also be sent as supplements to each member of the Commission, after the application is submitted;
- The financial disclosure information requested in the application, inclusive of a completed Form 6 (Full and Public Disclosure of Financial Interest);

- Any additional information which you feel may be helpful to the Commission in assessing your qualifications.

3. It is suggested that you submit your application as soon as it is prepared and well before the deadline.

4. After the deadline for submitting applications, the Commission will determine which applicants to interview. If you are to be interviewed, you will be contacted to confirm date, time and location.

5. The interviews will be conducted on Monday, December 7, 2015 at the offices of Gray Robinson, located at 401 East Las Olas Blvd., Suite 1000, Fort Lauderdale, FL 33301.

6. As you know, all proceedings of the Commission are open to the public except for deliberations. Accordingly, you should not expect your application and/or information to be kept confidential.

7. If an applicant is nominated, all materials attached to the original application will be submitted to the Governor and the Governor's office may ask for additional copies of same.
